BACKGROUND: <p>On April 22, 2024, Lee County Port Authority advertised RFB 24-0019MC Purchase and Delivery of Diesel and Unleaded Fuel for Lee County Port Authority utilizing the Port Authority's automated procurement system. The scope outlined in the RFB includes the purchase and delivery of diesel and unleaded fuel for use at RSW and FMY.</p> <p>LCPA received one qualifying bid, from Palmdale Oil Company LLC, with a per gallon markup of \$0.1485 for diesel and unleaded fuel. These prices represent the vendor's mark-up amount, excluding sales tax, above the current base price per gallon list on the Oil Price Information Service (OPIS). The per gallon markup represents a 19% increase from the current contract, which was signed in 2019, and is consistent with current market conditions and inflationary impacts of the last five years.</p> <p>The total spend through this service provider agreement is estimated between \$750,000 and \$1,250,000 annually based on the market price of fuel, and any additional equipment required to support the numerous capital projects expected to come online during the term of this contract.</p> <p>Request Board award RFB 24-0019MC for the Purchase and Delivery of Diesel and Unleaded Fuel for Lee County</p>
