10. **BACKGROUND:**

On September 3, 2020, the Board approved Service Provider Agreement RFB 20-31MLW Runway Rubber Removal with TRP Construction Group DBA Danton Hydroblasting, LLC to perform rubber removal and pressure cleaning on RSW's runway and taxiways for an initial term of two years. This contract included the option for LCPA to exercise two (2) two-year extensions. On January 19, 2023, the Board approved the first extension set to expire on September 30, 2024. LCPA requests the Board approve the final two-year extension with the existing contractor, maintaining the same terms and conditions as the initial contract term, at an estimated annual amount of \$77,000.00. The term of the renewed contract will commence on October 1, 2024, and expire on September 30, 2026, with the extension agreement signed by both parties.
