**LEE COUNTY PORT AUTHORITY**  
**SECOND RENEWAL AND EXTENSION OF SERVICE PROVIDER AGREEMENT**  
**RFP # 18-28**

THIS SECOND RENEWAL AND EXTENSION is made and entered this 6th day of March, 2025, between the **LEE COUNTY PORT AUTHORITY**, a political subdivision and special district of the State of Florida ("AUTHORITY"), at 11000 Terminal Access Road, Suite 8671, Fort Myers, Florida, 33913, and **UNITED DATA TECHNOLOGIES, INC.**, a Florida corporation, ("PROVIDER"), at 2900 Monarch Lakes Blvd., Ste. 300, Miramar, FL 33027, Federal Identification Number 65-0566138.

**WITNESSETH**

**WHEREAS**, the Parties entered into a Service Provider Agreement ("Agreement") dated January 18, 2019 for Provider to furnish/provide, install, test and maintain a unified communications system for Southwest Florida International Airport and Page Field General Aviation Airport in Fort Myers, Florida specified in RFP # 18-28; and

**WHEREAS**, the First Renewal of the Agreement for three (3) years, and expires on January 18, 2025; and

**WHEREAS**, the Authority has the option to renew and extend the initial term for up to two (2) additional 3-year periods from the expiration date of the initial term; and

**WHEREAS**, to exercise its option to renew and extend the First Renewal of the Agreement, or any renewed/extended term of this Agreement, the Authority must give the Provider written notice of its intent to exercise its option to renew and extend at least ninety (90) days licensing the services to be provided by the Provider under this Agreement; and,

**WHEREAS**, the Authority provided timely written notice of its intent to exercise its option to renew and extend the Agreement to the Provider; and

**WHEREAS**, any renewed/extended term must be agreed to in writing and executed by

the Parties with the same formality as this Agreement.

**NOW, THEREFORE,** in consideration of the above premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby extend and renew the Agreement as follows:

1. Recitals. The above recitals are true and correct and incorporated into and made a part of this Second Renewal and Extension by reference.
2. Renewal and Extension of Initial Term. The Parties hereby agree that the Agreement is renewed and extended for a final (3) year term.
3. Except as amended by this Second Renewal and Extension, all terms and conditions of the Agreement shall remain in full force and effect.


