10. **BACKGROUND:**

On March 28, 2024, LCPA advertised a Request for Bids (RFB) for the Concourse E Passenger Boarding Bridges (PBB's) as part of the RSW Terminal Expansion Phase II improvements. The improvements associated with this contract consist of furnishing labor, materials, equipment, miscellaneous construction services, insurance, delegated engineered shops drawings by a State of Florida licensed engineer, bonding, taxes, permits and incidentals for the work shown on the bid documents. This project consists of supplying and installing fourteen (14) new Passenger Boarding Bridges for the new Concourse E to match the existing architectural appearance of the existing Passenger Boarding Bridges. The scope of work will include, but not limited to, all mechanical, plumbing, electrical, fire alarm, communication, security, structural concrete pile caps, attachment of PBB's to the building, and tie downs to secure the bridges.

A Pre-Bid meeting was held on April 11, 2024 to further present and discuss the project and answer questions from prospective bidders. On May 22, 2024, the following three (3) bids were received:

- Oshkosh AeroTech, LLC = \$20,191,215.68
- TK Airport Solutions, Inc. = \$20,421,364.37
- AERO BridgeWorks, Inc. = \$20,997,400.00

Background (continued)

After publicly opening the bids, Port Authority staff and AtkinsRealis (Engineer of Record) evaluated the bids and determined that all received bids were responsive when compared with the requirements of the Request for Bids and that Oshkosh AeroTech, LLC was the lowest, responsive, and qualified bidder in the amount of \$20,191,215.68. A minority participation goal was set at 12%; however, based on information received, Women/Minority Business Enterprise (W/MBE) services have been committed at 13%.

All expenditures of work associated with this contract will be under the established Total Project Budget and in accordance with Board-approved contract and Purchasing Policies and all project contingencies are controlled by the Port Authority
