

**AFFIDAVIT OF COMPLIANCE WITH SECTION 287.138 and 787.06, FLORIDA STATUTES**

Before me, the undersigned authority, personally appeared Ed Maher, who, after being first duly sworn, deposes and says of his or her personal knowledge the following:

1. Affiant is the AVP-Network-Reg of Cellco Partnership d/b/a Verizon Wireless which does business in the State of Florida, hereinafter called the "Organization."
2. Organization, pursuant to Section 287.138, Florida Statutes, certifies that (1) Organization is not owned by a government of a foreign country of concern; (2) a government of a foreign country of concern does not have a "controlling interest" in Organization, as defined by Section 287.138(1)(a), Florida Statutes; and (3) Organization is not organized under the laws of or has its principal place of business in a foreign country of concern. For the purposes of this affidavit, foreign country of concern means the People's Republic of China, the Russian Federation, the Islamic Republic of Iran, the Democratic People's Republic of Korea, the Republic of Cuba, the Venezuelan regime of Nicolás Maduro, or the Syrian Arab Republic, including any agency of or any other entity of significant control of such foreign country of concern, as defined in Section 287.138(1)(c), Florida Statutes, as amended from time to time.
3. This Affidavit is executed by the Organization in accordance with Section 287.138, Florida Statutes, for the purposes of preventing Lee County and Lee County Port Authority from entering contracts with foreign entities of concern which would provide Organization access to an individual's personal identifying information.
4. Organization, pursuant to Section 787.06, Florida Statutes, certifies that Organization does not use coercion for labor or services as defined in Section 787.06, Florida Statutes, as amended from time to time.
5. This Affidavit is executed by the Organization in accordance with Section 787.06, Florida Statutes.
