Scope of Services;

- Provide electrical permits as required
- Install dispenser sidewall entry in 51 dispensers and run conduit overhead to a Pneumercator LC2000 to be located on new frame support on canopy column at each agency (seven total)
- Pull power through e-stop conduit
- Fabricate and install conduit supports as needed on islands and beneath canopy.
- Install 51 non-discriminating sensors in dispenser sumps and wire to leak console
- Run a communication wire from leak console to shunt trip breaker for positive shut down
- Install a keyed bypass switch for operator
- Provide worker protection barriers and clean work site from construction debris.
